# **Reconfirmation Meeting for April**

### Reconfirm instructional delivery method:

Students enrolled face to face at KPS could receive remote instruction if face to face learning needs to be put on pause for a short to long period of time. Our face to face students are receiving instruction through the previous vetted curriculum. Remote instruction will continue with this curriculum.

Students enrolled in the Kalkaska Virtual Program K-5 receive 100% of instruction using Accelerate GenNet programming through the LMS of Canvas through virtual teachers (K-5 and 6-8).

High school Virtual Program students are instructed through Michigan Virtual with a Kalkaska mentor to monitor progress.

### Reconfirm how instruction will be delivered for each grade level:

## Elementary (Grades K - 5):

Students enrolled in the Kalkaska Virtual Program receive instruction using Accelerate GenNet programming through canvas supplemented with approved district curriculum and google meets/videos by teachers.

Birch St. / Rapid City / Cherry St. Virtual Learners (K-5): We have a virtual-only teacher instructing students. Teacher splits the week up into content, group meets, small group meets and family meets.

We have added additional support through a long term substitute for K-5. Her focus will be helping more on the backend of the program and to help with targeted sections.

# Middle School (Grades 6 - 8):

Students enrolled in the Kalkaska Virtual Program receive instruction using

Accelerate GenNet programming through canvas supplemented with approved district curriculum and google meets/videos by teachers.

Middle School Virtual Learners: Have a virtual-only teacher instructing students. Specials offered virtually to students.

#### High School (Grades 9 - 12):

Students enrolled in the Kalkaska Virtual Program receive instruction from Michigan Virtual teachers in their core content areas and specials. School offers mentors that are in constant contact with students about progress in Michigan Virtual and also delivers our advisory content including SEL and team-building.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

Face to face population receives services as normal.

During extended remote learning, KPS has been offering Face to Face small group instruction to students with IEPs or lacking reliable internet service.
